Kevin's relevant risk management experience is based on both assessing risks and developing internal controls in response to risks as well as the development and delivery of risk management training.

Kevin is a highly experienced facilitator and practiced in applying adult learning principles, facilitation and presentation techniques. Kevin has more than 20 years experience of designing and delivering training programs in strategy, finance, accounting and management. His relevant experience in risk assessment, risk management and review of internal controls includes:

- Delivering Comcover's suite of risk management training since 2013, including: *Risk* Management Fundamentals; Embedding a Risk Management Framework; Policy and Project Management; Fraud Control; and Business Continuity Management.
- Developing and facilitating Comcover's new SES risk management training program, A Strategic Perspective to Managing Risk, incorporating a facilitated face-to-face workshop for senior executives in the Australian Public Service.

Experience – Financial and Budget Management

Kevin's relevant financial and budget management experience is based on both developing financial management policies and procedures, implementing financial management information systems and developing and managing budgets as well as the design, development and delivery of financial and budget management training. This experience has been gained over more than 20 years and includes:

- Consulting to the Department of Finance (Finance) and providing strategic and financial management advice within the Budget Group, including the Budget Co-ordination Unit. This included working in Budget Group over two Budgets and Mid-Year Economic and Fiscal Outlook (MYEFO) cycles as well as drafting chapters of the Budget Group Manual, including: Explanation of the Accrual Framework; Guide to the Budget Papers; Explaining Resourcing Fiscal, Cash and Operating Balances; and Costing New Policy Proposals.
- As part of the first accrual Budget Kevin provided briefings on the accrual budget concepts to Ministers, Shadow Ministers, Senators and Members of Parliament. This was conducted on behalf of the Office of the Minister for Finance, the Hon. John Fahey, MP.

Experience – Coaching

Kevin's relevant executive coaching experience is focused on assisting executives to apply business management principles including strategic analysis, strategy development, financial analysis, costbenefit analyses and development of performance information. His relevant experience includes:

- Coaching senior executives within the Department of Finance on the implementation of budget reforms and the impact of budget decisions on the General Government Sector budgeted balance sheet, underlying cash balance, fiscal balance and headline cash balance.
